- ▶ Center boasts a signalized entrance on heavily traveled Route 7 / Harry Byrd Highway

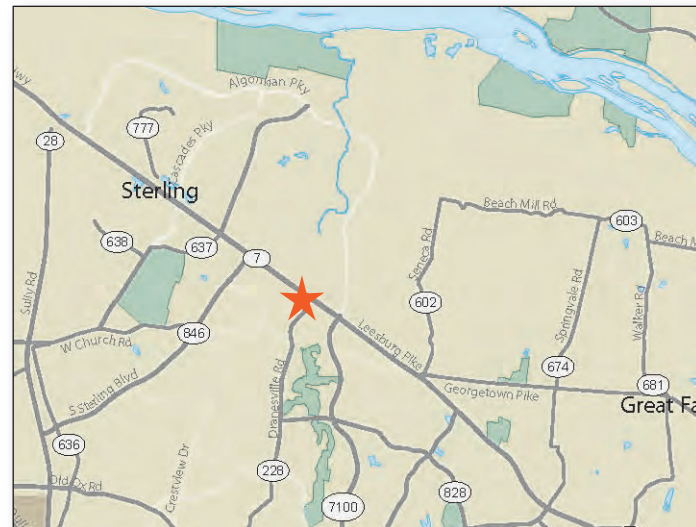

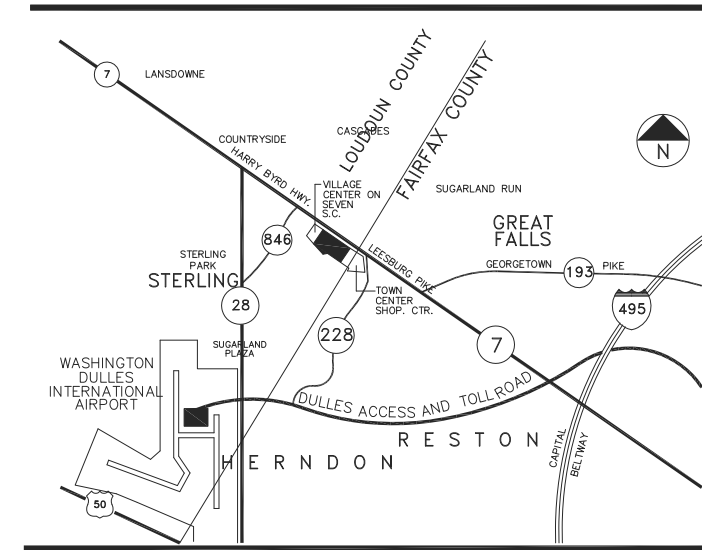
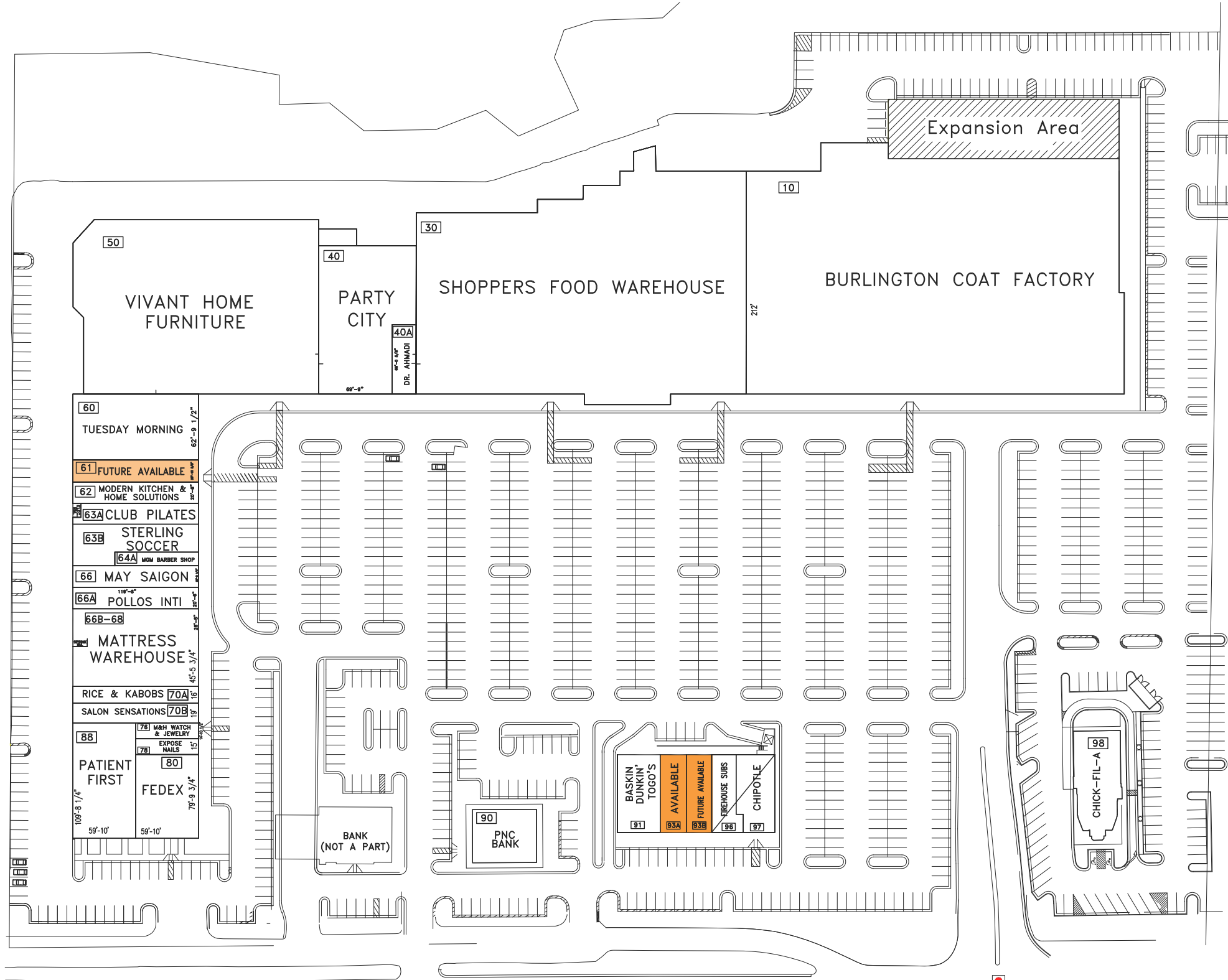
