- ▶ 57% of county residents have a Bachelor's degree or better

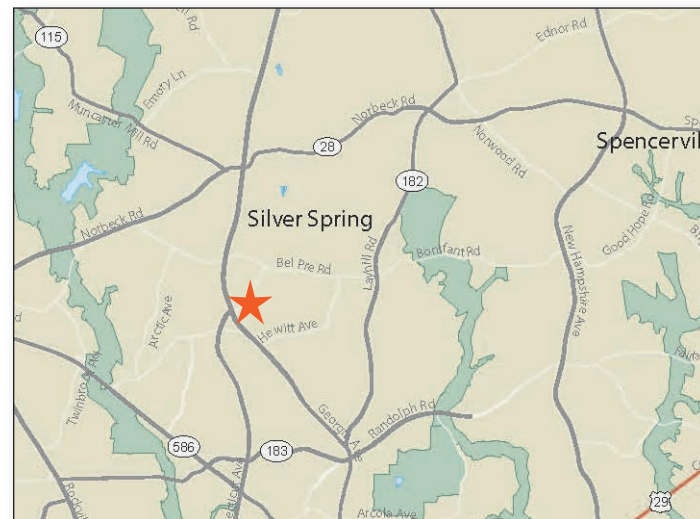

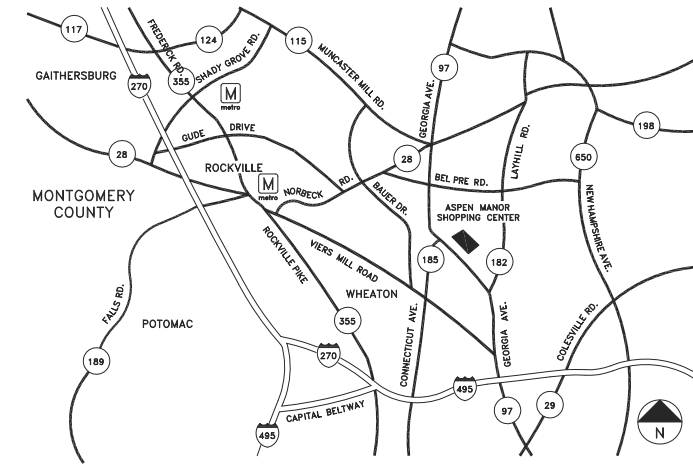
