- ▶ 60% of the county’s residents have a Bachelor’s degree or higher

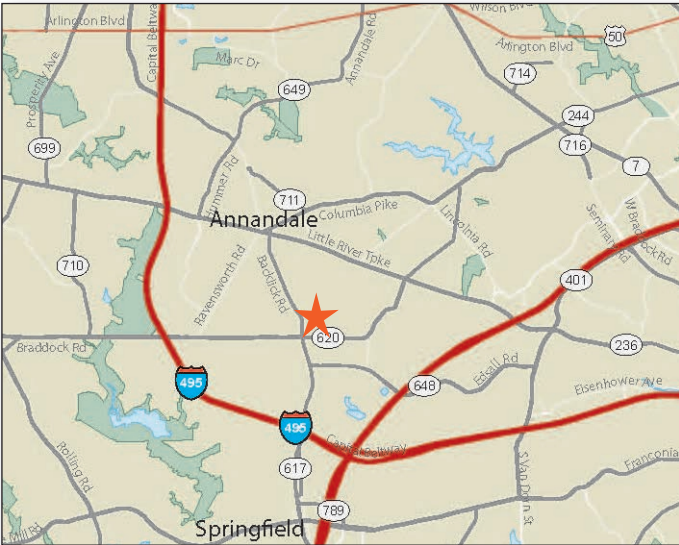

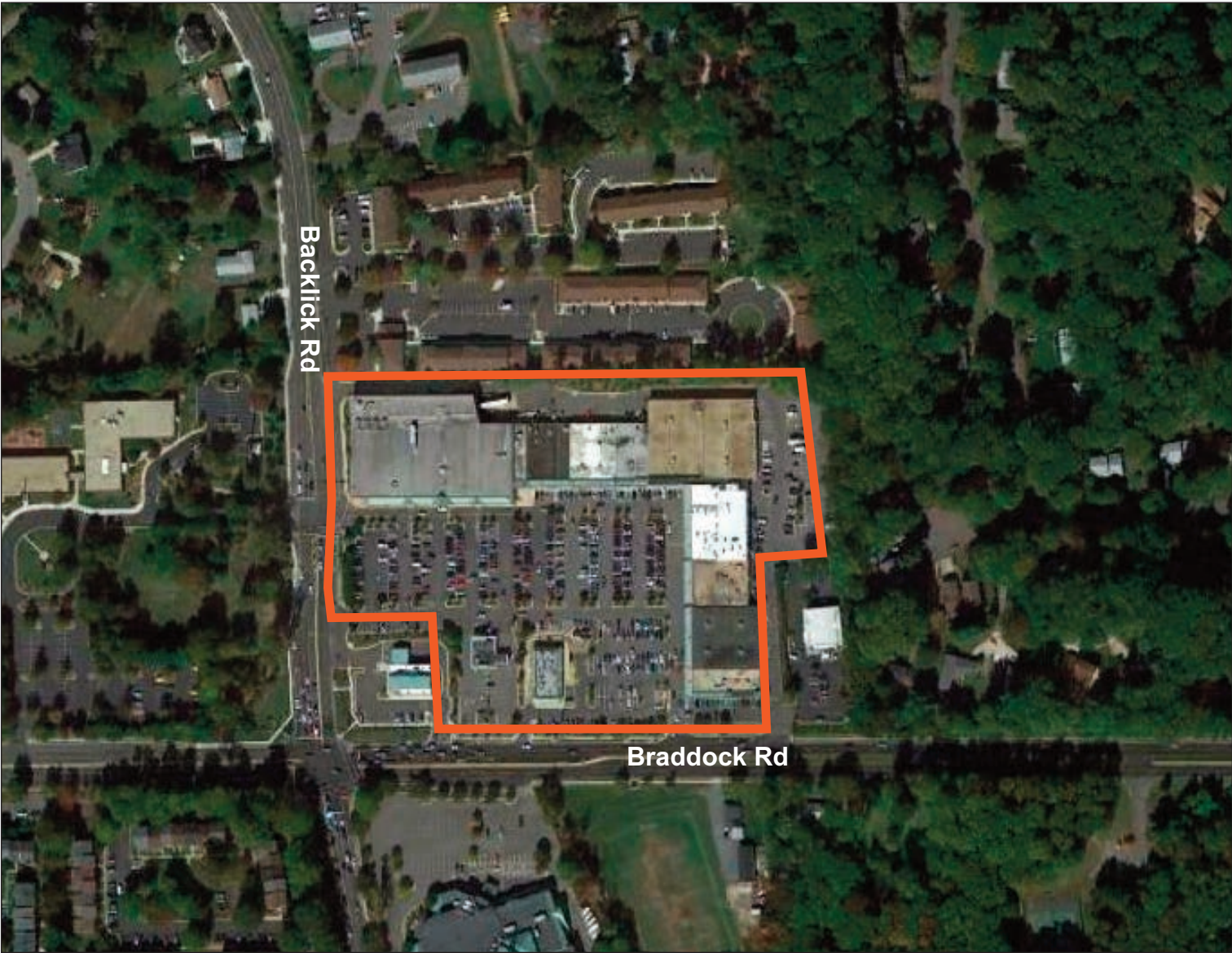

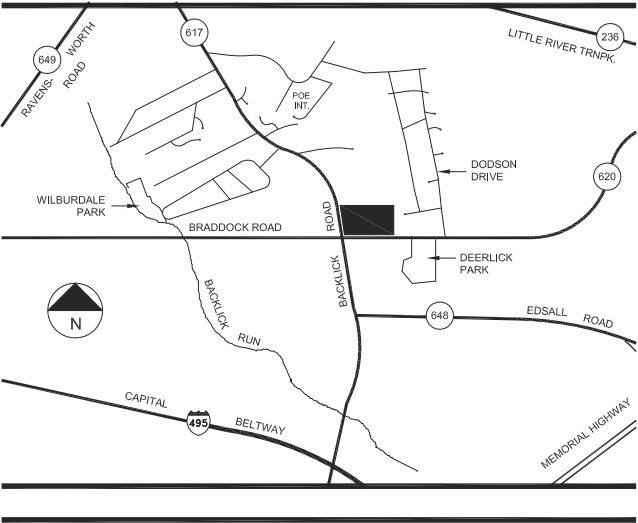
